2. Threats diagram update	Guy Castley
Guy Castley presented the diagrammatic representation of threats and their interactions.

'lack of knowledge' and how this is phrased and referred to in the body of the plan. The diagram needs to reflect the text / narrative in the Recovery Plan. Work also needs to be undertaken on a caption or some narrative to describe the diagram.

Action: Sam to update matrix of regional threats and attempt to re-order threats in draft plan based on significance	
4. Objectives, strategies and actions	Daniella Teixeira
Prioritising actions - Dani would like to see cost estimate in the Plan (this could be a scale-based cost, such as low-cost, moderate-cost, high-cost). A cost-benefit analysis alongside likelihood of success and benefit to the species, could be beneficial. Tim commented that costs are now being removed from Recovery Plans but agreed that a tiered system for costs would be beneficial - a relative measure of cost-effectiveness.	
Tim also mentioned that prioritisation of actions / strategies based on region could be beneficial. This work has largely already been completed.	
Action: Dani to find out if other Recovery Plans have included costs / used costs in a prioritisation framework. Lauren mentioned that there is a Business Plan for their region for the eastern bristlebird.
